

POWER OF ATTORNEY

(SQM) (the "Meeting") which has been summoned to be held at 10:00am on Wednesday, April 24, 2024 or in the meeting held in its replacement if the Meeting cannot be held due to lack of quorum or defects in its summons or its suspension by the Chilean Commission for the Financial Market pursuant to the provisions of Article 63 of Law No. 18,046 or due to any other circumstances.

In the exercise of this mandate, the above identified representative or that person that the former agent delegates this mandate to- or the person that the latter agent may, in turn, delegate this mandate to, and so on, may make use in the Meeting of each and every one of the rights that correspond to me as Shareholder of SQM in conformance with the law, the Chilean Corporation Regulations, and the Company By-laws.

I hereby confer this power of attorney for the entire amount of shares registered in my name at SQM's Shareholders Registry five business days prior to the date of the Meeting. This power of attorney may only be understood as revoked by another power of attorney that, subsequent to that date, I grant in favor of another person other than the agent-representative designated earlier. Likewise, if two or more powers of attorney are presented with the same date, issued to various different people, they may not be considered for the effect of quorum and voting at the Meeting.
